Sub: Budget and training module for the conduct of field level induction-cum-GPDP training programme for the ward members.

Madam/Sir,

In inviting reference to the letter and subject cited above this is to inform you that sanction order has been given vide aforesaid letter for the conduct of "Induction-cum-GPDP" training programme for the PRI under Rastriya Gram Swaraj Abhijan for the year 2017-18. Accordingly budget was communicated for the Induction-cum-GPDP training programme for the elected representatives of PRIs of 3 days duration.

In the above context, the following clarification is given for conduct of 3 days Induction-cum-GPDP training programme for the Ward Members.

1. The budget communicated vide the above sanction order i.e- Rs.85,330/- per training programme of 3 days duration for 40 participants is also applicable to the Ward Member. The copy of the budget is once again communicated for your kind reference at Annexure - I.
2. The Training for Ward Members will be of 3 days duration. The copy of the training module is given in Annexure - II.
3. The DRDAs have been released with fund for conduct of training programme for the Block Resource Groups and GP Planning Unit. Since, after the PRI Election during Feb - March 2017, new elected representatives have assumed office, you are requested not to conduct training programmes for the Block Resource Groups and GP Planning Units. The fund already released against the same may be utilized for the Induction-cum-GPDP Training Programme of the Sarpanches, PS Members and Ward Members as per the budget communicated by SIRD&PR. In case, the districts have released the funds to blocks for conduct of GPDP Training for GP Planning Unit may be retrieved the same from blocks and utilize it for the Induction-cum-GPDP Training Programme.
4. The DRDAs are to submit Utilization Certificate for the fund released for GPDP in order to claim fund for Induction-cum-GPDP Training Programme. In case the unspent balance out of GPDP Training is not sufficient enough to conduct the Induction-cum-GPDP Training Programmes for the Sarpanches, PS Members and Ward Members, they may request SIRD&PR for release of fund. The formats and checklists for the Induction-cum-GPDP Training Programme for the Ward Members remains same that of Sarpanches communicated earlier.
