**Sub: Activities to be taken up to roll out the People's Plan campaign for Gram Panchayat Development Plan during 2<sup>nd</sup> October to 31<sup>st</sup> December 2018.**

**Madam/Sir,**

Ministry of Panchayati Raj, Govt of India has communicated all the states to undertake Gram Panchayat Development Plan (GPDP) on campaign mode during 2<sup>nd</sup> October to 31<sup>st</sup> December, 2018.

Following are objectives of the campaign:

- Strengthening the role of PRI representatives and SHG Women under DAY-NRLM in the conduct of effective Gram Sabha
- Public disclosure on Schemes, Finances, etc. of all Programmes in Gram Panchayat Office and on Gram Samvaad App
- Structured Gram Sabha meetings spread over from 2nd October – 31st December, 2018, ensuring presence and presentation by frontline workers/Supervisors of all 29 Sectors in XI Schedule
- To strengthen the use of Plan Plus software under PES application for providing for a pragmatic and holistic Gram Panchayat Development Plan

As per the instruction of Ministry of Panchayati Raj, Govt of India and subsequent decision taken by PR & DW Department, Govt of Odisha, I am directed to convey the following activities to be carried out by districts during the campaign:

1. PD, DRDA will be the Nodal Officer at district level and BDO to be the Nodal Officer at Block level for overseeing the campaign.
2. Gram Rozgar Sebaks will act as facilitators at Gram Panchayat level. The Facilitator is to perform the following activities during the campaign:
  - To carry out Mission Antyodaya Survey by using Mission Antyodaya Mobile APP.
  - Facilitate the conduct of special Gram Sabha for preparation of GPDP
  - Ensure Community Mobilization including vulnerable groups in the Gram Sabha


- Submission of a report regarding conduct of Gram Sabha on the GPDP portal [www.gdpd.nic.in](http://www.gdpd.nic.in)
  - Supporting preparation of Gram Panchayat Development Plan
  - Upload GPDP in Plan Plus software of MoPR, Gol
3. SIRD & PR will conduct Training of Trainers for the Mission Antyodaya Survey at the earliest. They will impart training to the GRS as facilitators at district level.
  4. Districts are to organize special Gram Sabhas for discussion and preparation of Gram Panchayat Development Plan as per the following Calendar:

Date	Areas of Discussion
2 <sup>nd</sup> October 2018	Discussion on Preparation of Gram Panchayat Development Plan
26 <sup>th</sup> October 2018	Assessment of Needs at Gram Panchayat level based on the Gaps on infrastructure, livelihood, basic services and other areas
30 <sup>th</sup> November 2018	Approval of the final Projectised Gram Panchayat Development Plan

5. All the Front line workers of different Line Departments related to 29 subjects of XI Schedule of the constitution such as Agriculture, Soil Conservation, Minor Irrigation, Animal Husbandry, Fishery, Forest, Rural Housing, Rural Water Supply and Sanitation, Odisha livelihood Mission & MGNREGS of PR & DW Deptt, School and Mass Education, Women and Child development, SC & ST Development, Health & Family Welfare, Rural Electrification, Public Distribution System are to be deputed for structured presentation on their programme activities and related discussions in Gram Sabha meetings on the above dates.
6. The photographs of Gram Sabha meetings are to be geo-tagged and uploaded in the web portal of GPDP [www.gdpd.nic.in](http://www.gdpd.nic.in)

I would therefore request you to kindly declare PD, DRDA and BDO as Nodal Officer at District and Block level respectively and GRS as Facilitator is also to be nominated at Gram Panchayat level for the campaign.
