- To enable the participants to integrate NRM with GPDP from COVID 19 perspective.



The participants (no escorts) will be provided with free boarding and lodging during the training programme.

Keeping in view the COVID 19 safeguard measures the following guidelines need to be mandatorily followed while nominating the participants:

- Participants with co-morbid conditions should not be nominated.
- The participants who are in isolation / having any family members staying in isolation in the same premises should not be nominated for the training.
- The participants have to submit a self declaration, that they are not affected by Corona virus (both symptomatic and asymptomatic) during the time of registration at SIRD&PR.
- Persons already affected by the virus should give declaration that their quarantine period is over and they are free from any type of symptoms related to Corona infection.
