Sub: Revision in the budgetary provision for the Training Programme on Gender Sensitive GPDP

Ref: This Office Letter No. 703 (60) dt 26.02.2019

Madam / Sir,

With reference to the letter and subject cited above, I am to inform you that all the DRDAs were requested to organize training programme on Gender Sensitive GPDP following the modalities as well as the budgetary provision provided by SIRD&PR. However, it has been brought to the notice of SIRD&PR by few APDs (Trg) as well as CPOs that providing sitting fees only to the elected representatives of PRIs and the members of NGOs, CBOs are creating discontentment among the other participants such as ASHA, Anganwadi Worker, Jogan Sahayak ^{GPDP} who are not in the pay roll of Government.

In the above context, it has been decided to revise the budgetary provision sent earlier by SIRD&PR. The sitting fees @ Rs. 200/- per day per participant can be provided to all members of GP Planning Unit other than the Government Functionaries on the last day of the training. The budget is meant for 40 participants. However, in case of increase / decrease in the number of participants, the sitting fee may be calculated proportionately within the approved ceiling of the budget circulated earlier vide above letter under reference.

Hence, you are requested to kindly ensure the payment of sitting fee to the GP Planning Unit members namely ASHA, Anganwadi Worker, Jogan Sahayak ^{GPDP} along with elected representatives of PRIs, representatives of CBOs and NGOs.




